ROAD TRAFFIC REGULATION ACT 1984

(LANCASTER AND PRESTON CITY) (AMENDMENT TO PERMIT
PARKING PROVISIONS) ORDER 202*

NOTICE IS HEREBY GIVEN that Lancashire County Council propose to make the above Traffic Regulation Order under Sections 45 and 46 to the **Road Traffic Regulation Act 1984**, as amended, the effect of which will be to:

1. Revoke the "Lancashire County Council (Pitt Street, Preston, Preston City) (Revocation, Amendment to Parking Provisions, Prohibition of Waiting and Prohibition of Loading) Order 2021" insofar as it relates to Schedule 2.
2. Amend the "Lancashire County Council (Various Roads, The Whole Of Lancashire) (Permit Parking Order Amendment (No1)) Order 2019" as set out below:
